Dear Brethren:

In accordance with the provisions of Articles 200 to 209 inclusive of the *Constitutions of the Supreme Council*, you are notified that the One Hundred Thirty-Ninth Convocation of the Illinois Council of Deliberation will be held in the City of Peoria, Illinois, Saturday, June 28, 2008, at 1:00 P.M. for the transaction of business concerning the welfare of the Ancient Accepted Scottish Rite of Freemasonry in the State of Illinois.

MEMBERS

Article 200 of the Constitutions of the Supreme Council defines those who are entitled to seats in the Council of Deliberation as follows:

"The Active, Emeriti, and Honorary Members of the Supreme Council accredited to each State; The Past First and Past Second Lieutenant Commanders of the Council of Deliberation; the Past Commanders-in-Chief of Consistories; the Past Most Wise Masters of Chapters of Rose Croix; the Past Sovereign Princes of Councils of Jerusalem; the Past Thrice Potent Masters of Lodges of Perfection; those members of Subordinate Bodes in the State who have received the Meritorious Service Award from the Council of Deliberation of such State, and the first three elected officers together with such other officers as are duly elected by a Subordinate Body and designated to be a members of the Council of Deliberation, as well as s the Treasurer and the Secretary of Subordinate Bodies, shall constitute a Council of Deliberation for that State of which the Deputy for that State shall be ex-officio Illustrious Commander-in-Chief."

PROXIES

Article 201 of the Constitutions of the Supreme Council defines the use of proxies as follows:

"Any officer of a Subordinate Body of the rite who is entitled to a seat in the Council of Deliberation from his State, but is unable to be present at any session of such Council, may appoint as his proxy to act in his stead any member of such Subordinate Body, provided, however, that such proxy shall not represent more than one member of such Council."

Presiding Officers are expected to attend in person. Any officer who is unable to attend may give a written authority to another member to act. The person so appointed must present his authority, in writing, to the Secretary of the Council, signed by the officer whom he represents.

The wearing of caps and jewels of office, both past and present, is requested.

You have made us for yourself, O Lord, and our hearts are restless until they find rest in you. Direct us in all our doings with your most gracious favor, and further us with your continual help, that in all our works, begun, continued and ended in you, we may glorify your holy name, and finally by your mercy obtain everlasting life. Amen. Please be seated.

Faith, Hope and Love



P. Alvin Lair, 32°, MSA Prior

Our task today is to remember and honor our departed brethren. We are concentrating on the concept of faith, hope and charity. The King James Version of the Bible translates I Corinthians, Chapter 13 using the word "charity" which means "love." To emphasize the meaning "love," I will use the New International Version which translates the key word as "love." Those of you who know Masonic ritual will notice some differences in the N.I.V. translation.

"If I speak in the tongues of men and angels, but have not love, I am only a resounding gong or a clanging cymbal. If I have the gift of prophecy and can fathom all mysteries and all knowledge and If have a faith that can move mountains, but have not love, I am nothing. If I give all I possess to the poor and surrender my body to the flames, but have not love, I gain nothing. Love is patient, love is kind. It does not envy, it does not boast, it is not proud. It is not rude, it is not self-seeking, it is not easily angered, it keeps no record of wrongs. Love does not delight in evil but rejoices with the truth. It always protects, always trusts, always hopes, always perseveres. Love never fails.

But where there are prophecies, they will cease; where there are tongues, they will be stilled; where there is knowledge, it will pass away. For we know in part and we prophesy in part, but when perfection comes, the imperfect disappears. When I was a child, I talked like a child, I thought like a child, I reasoned like a child. When I became a man, I put childish ways behind me. NOW—we see but a poor reflection—as in a mirror; THEN—we shall see face to face. NOW—I know in part; THEN—I shall know as I am known.

And now these three remain; faith, hope and love. But the greatest of these is love.

Faith, Hope and Charity/Love.

Faith is defined as the "the substance of things hoped for, the evidence of things not seen." Or "faith is being sure of what we hope for and certain of what we do not see. This is what the ancients were commended for." "Without faith it is impossible to please God, because anyone who comes to Him must believe that He exists and that He rewards those who earnestly seek Him.

Abraham stepped out in faith, obeyed God and traveled where God directed him. Because he did this he became known as "the father of all who believe." God made at least seven promises to Abraham. Because Abraham acted in faith, history tells us that all seven promises were kept by God. The Old Testament is filled with examples of God keeping His promises. One of God's promises to Abraham was "all peoples on earth will be blest through you." Jesus of Nazareth is a descendant of Abraham and is one through whom all peoples on earth will be blessed, if they accept him.

Abraham's faith and the faith of others is proof of God's existence and that He keeps His promises. God is faithful. Without faith, we have no hope.

Let us distinguish between the words "wish" and "hope." When we make a wish, we are expressing an idle dream that something might happen with no expectation that it will actually happen. For example: I wish I might win the million dollar lottery. You know I am not going to win the the lottery because, first, I would have to buy a ticket and even If I do buy a ticket, everybody in the whole world would have to win before I would. It might be fun to fantasize about spending the lottery winnings, but it isn't going to happen.

Job 15:7 says: "for there is hope of a tree if it be cut down, that it will sprout again and the tender branch thereof will not cease." We know that cutting down a tree does not necessarily mean the death of the tree. Have any of you tried to get rid of an osage orange tree by cutting it down and leaving a stump? What happened? It grew back stronger than before. Coppice cutting is practiced in some countries. This is the cutting down trees for various purposes with the expectation that the stump will sprout new growth which can be cut later after the new growth has reached the desired size.

When as Scottish Rite Masons we say "Our hope is in God," we are not saying we that we wish for something. We are saying that we expect something to happen with the certain knowledge that it will happen because we know that God keeps his promises. He kept His promises in the ancient times and He keeps His promises today.

We have considered faith and hope. Now we consider charity or love. Jesus said, "A new command I give you: Love one another."

How do we display our faith? By loving one another. Also by loving those who are not lovable. Those who are disagreeable and downright impossible to get along with. That love is demonstrated by our actions. Love is not only an emotion or feeling, it is action. Brothers in the Ancient Accepted Scottish Rite demonstrate their love for others in their community service, church worship and the assistance for those who need assistance.

How much are we expected to love one another? This love extends to the ultimate sacrifice. "Greater love hath no man that this-that a man lay down his life for his friends."

There are many examples of those who have been wiling to die for others and those who have actually died for others. The Four Chaplains who gave their life jackets to sailors who had none and went down with the ship in World War II and exemplified in our Scottish Rite Degree work. Those fire fighters, who went into the towers in New York that were hit by the airplanes that were guided by

terrorists, went in knowing that they would would not get out. I expect that they thought that going in would help save the lives of others. People they could not have known.

Remember the battle cry of Constans, who left his vigil to defend the people of the city from the attackers. "My hope is in God!" Our hope is in God. Because our hope is in God, we love Him and we love our fellow man. Because we love others, we help them.

Our departed brethren loved others and demonstrated that love through their support of their local community, churches, service organizations, agencies and Masonic bodies. As Scottish Rite Masons they also demonstrated that love through their support of the Scottish Rite Charities. Due to their foresight and sacrifices we are now issuing hundreds of scholarships each year, particularly in the health care fields where there is a severe shortage of workers especially in the nursing field.

Our departed brethren have heard the welcome words, "Well done, thou good and faithful servant." They have relied upon His infinite love, waited in patient hope for death to be swallowed up in victory and have been welcomed home to that house not made with hands eternal in the heavens, where no discordant voice shall arise and all the soul shall experience shall be perfect bliss and all it shall express shall be perfect praise and love divine ennoble every heart and hosannas exalted employ every tongue.

Brethren, please rise and reverently listen to the names of our departed brethren are read.

The collar we had for Nick was taken by the burglar so Monday we were hurrying to get another chain collar in for this ceremony today. So you received a brand new one. The guy on the street got a brand new one too, but he doesn't know what he has.

The 32° Masonic Learning Centers for Children within the Illinois Council of Deliberation are up and running. Danville is on line now processing children and full as are nearly all the centers. This charity we have been working on the last several years is successful. Thank you Danville for all the work in getting up and running.

The annual budget for this fiscal year ending April 20, 2008 we had a total income of \$104,472.91 vs. expenses of \$92,789.65 which produced a net income of \$11,683.26. Looking forward to our next fiscal year, we estimate in income of \$85,500.00. We estimate total expenses of \$79,500.00 which would produce a net income of \$6,000. PREPRINTED FINANCE COMMITTEE BUDGET REPORT

Illustrious Commander-in-Chief, Officers and Members of the Illinois Council of Deliberation:

The Finance Committee proposes the following budget for the fiscal year for your consideration. The budget anticipates an excess of income over disbursements of \$6,000.

The amount of income from the per capita is based on \$3.00 times the Fourth Degree members on the 15th of June each year—the fiscal year just ended—which is billed in the following year. Estimated investment income is an estimate based upon the following year.

The actual net cost of last year's Annual Meeting was \$20,965.20, and is expected to be slightly lower this year. Other budgeted amounts have been increased and decreased based on last year's actual experience.

The combination of decreased anticipated income and the expected increased disbursements as caused a smaller surplus for fiscal year 2008-2009.

Ill: Benny L. Grisham, MSA, 33°, Active for Illinois:

Most Worshipful Grand Master, Illustrious Commander in Chief, Illustrious East, my brethren all:

I have been asked to give you membership report, I think everyone here knows our membership status. But there will be a report.

I might start with a little story, it really has nothing to do with membership. But, it does reflect how far we have come in some respects. Some of you might know that a couple of months ago our house was burglarized. Last week, about 11:30 at night, I went outside to get a package off the porch

I noticed when I came home. There were no lights on and I'm standing there when a car pulls up across the street, then another and then a third. Three cars in our neighborhood which never be sitting there. I thought that was strange, but a young lady lives across the street and I thought maybe it was her boy friend. Pretty soon, a person darts towards one of the cars, opens the door and leans in. A second person cruise up and is leaning in the other side of the car. Now I'm starting the get the message, I'm just a little bit slow. Soon, the second person goes to the second car and gets into it. Now I know what's going on. I hollered over, "What's going on?" The engine starts on the car, on guy hops in the car, it starts spinning its wheels and I headed out to the street. The third person is running to catch the car and running along side it, and I'm chasing him. Of course, he was probably eighteen. The car never did stop to pick him up and he kept running. I could not run very far. When it was all over, I'm standing there thinking, I don't know what I would have done if I caught him. I never gave that a thought.

I will make a little presentation about the Membership Program we are operating here in Illinois. Once upon a time, some 40 years ago, these two large groups operated very successfully in our state. The Grand Lodge as a parent as a parent fraternity if you will, probably at that time had 150,000 members and had been in business for some 125 years and had seen its peak in membership some seven to ten years before. The Scottish Rite had no problem in attracting Masons who were proud to become part of history if you will, and they were justly proud to have the title of 32nd degree mason.

So there was no need to make any change.

Candidates at that time seemed to be always available and eager to join. Class sizes for these initiations were commonly in the range of 150 to 200 candidates

twice a year. Many of those who joined, never participated in the Valley activities and more importantly to our membership numbers, they never placed any demands on the Valleys to retain their membership. We all told ourselves there was no need to make a change and maybe that was true at that time.

During the next ten to twenty years, and even though all the class sizes the started to decline, we told ourselves no problem. So there was no need to make any change.

During the next ten to twenty years we saw the class sizes for our valleys continuing to decline to an almost unbelievable low number at times. Many members came to question the value of membership and many of us decided we have a problem and began to look at the need to make a change.

And during the last five years we have decided that we have a problem, not only in attracting new members but in retaining some of those faithful members we have had for many years because we have not fulfilled our commitment to them, fraternity, brotherly love and fellowship.

Have we now decided that we have a problem and we need to make a change? Brethren, we are making changes and we are making changes for the better.

Grand Lodge Membership Program

Last year in June, our Grand Master called a meeting of all the leaders of the various groups in Illinois to create a joint focus on membership for each of those groups. The membership presentations has been scattered throughout the state and are still ongoing. I am sure that our Grand Master feels that we are not doing enough yet, and that the program will expand. The fruition of the labors of the presenters has not yet been seen, but as with most programs it will take time for the planted seeds to grow.

Advertisement

The Grand Lodge officers, working with Brother Rick Kohn, have started an advertising program which consists of ten new billboards being placed around the state each month. The locations are scattered around the state in our major college cities. As a supplement to the billboard advertising program, newspaper ads have been placed in college newspapers with much the same theme as the billboards. This advertising program although not totally directed at college aged men, is renewing the recognition of the Masonic emblem in the minds of men of varied ages.

Website

Both the billboards and the newsletter advertising program direct a man to our new website and allows each man the opportunity get information about our fraternity and to ask for more membership information. The Grand Lodge currently receives between 30 and 40 requests a month for information about the fraternity.

Supreme Council

Our Supreme Council is working on several membership enhancement programs, hoping to help our Valleys create recognizable value in membership in

this fraternity. Recommendations like holding entertaining events for members on a monthly basis in lieu of business meetings that are not of interest to most members, having traveling degrees for the benefit of our membership, the creation of more Scottish rite clubs and possibly additional valleys are just a part of the many changes that are being implemented and considered.

As time and moves on and society changes, our valley operations must become flexible and be ready to meet the needs and expectations of our member's prospective members.

I would like to take just a little more of your time and share some additional information with you.

I would like to share with you, its a video we have been using at our membership presentations around the state. It is an amazing thing which demonstrates how old am I and how far away from reality am I now.

PREPRINTED MEMBERSHIP COMMITTEE REPORT

The Illinois Council of Deliberation and most of its Valleys have again struggled with membership recruitment during the past year. I believe that most of the Valleys are making needed changes in their reunion schedules and Degree presentations to become more relevant for our current and future members. By having Degree presentations at locations other than at the Valley building and taking our degrees to our members instead of requiring them to come to us has begun to make a difference for our recruitment and retention efforts. The Valleys in Illinois are becoming leaders in innovative programs that provide interest for our members who have varied interests.

The Grand Lodge has continued to provide Masonic membership lists for our Valleys on request. The new members in our Grand Lodge since June 1, 2007, total 1200 which is a slight decrease from last year's total. The Valley's in Illinois initiated 365 new members compared to 313 for the same period last year, which is a 16% increase as compared to a 25% decrease in new Masons in our State.

Brethren, as I stated in my report last year, the membership losses we are incurring would require any business to drastically change their marketing and products lines. I think the message has been understood by our Valley Officers and the needed changes are being made. Although we do not have all of the options available to a business, we are able to make many changes to return us to the real business of Scottish Rite, the business of providing our members with opportunities of fraternity, networking and enjoyment of fellowship with their fellow man.

At last year's Grand Lodge meeting a compact was agreed upon by all of the appendant bodies in Illinois to jointly utilize a unified membership program. Although the program has had somewhat a slow start, it is a program that will work for all of the Masonic groups in Illinois to not only grow our membership, but to provide a meaningful reason for our members to continue to be a part of

ANNUAL MEETING ILLINOIS SCOTTISH RITE SCHOLARSHIP FUND

At this time I am going to recess the Illinois Council of Deliberation (2:15 p.m.) and call into session the Annual Meeting of the Illinois Scottish Rite Scholarship Fund Corporation.

Treasurer Report, ISRSF

The first order of business will be a report of our Treasurer, who is unable to be with us this morning. Ill.: Barry D. Weer, 33° , has the information and will present it.

Ill∴ Barry D. Weer, 33°, Secretary, ISRSF:

Thank you Illustrious Commander-in-Chief. I am delighted to have the opportunity to share the Report of the Scottish Rite Scholarship Fund with you this morning.

On April 1, 2007 we opened the year with total assets of \$9,161,376. During the course of the year we received contributions \$48,201. We received dividends and interest on our investments of \$324,515. We had realized capital gains of where we sold some of investments of \$168,571. We had farm income, from a farm that was left to us in the Lexington area. We have that in cash rent and in the course of the year we realized \$9,989. Total income to the fund during the course of the year was \$551,277.

During the course of the year we distributed in scholarships, in our General and Lou Williams, Perkins, Kresin and Wilson scholarships \$419,575. A significant investment in the education of youth. We had expenses of investment fees to Harris fund managers we hired to assist with the investments of the Fund of \$57,862. We had administrative costs during the course of the year, primarily accounting and auditing of \$17,351. Total expenses were \$494,799. We had income greater than expenses. However during the course of the year, as many of you are aware it has been a relatively

volatile year in the stock market we have fair market value fluxuations of unrealized losses on investments of \$432,227. We actually had a net loss of \$375,829 ending the year on March 31, 2008 with a Fund value of \$8,785,527.

Our investment into the scholarships during the course of the year were that we supported 346 students. The Chairman of the Scholarship Committee will be reporting on that shortly and detail some of the scholarships.

I would like to indicate to you, that at today's Board of Directors' meeting, we were able to establish distributions next year from the Fund of \$444,000 plus for the year. Illustrious Commander-in-Chief, I move acceptance of the Treasurer's Report.

York Rite and Shrine have picked it up as a standard answer to the usual question "how do we increase membership?". Copies of the booklet are in all Scottish Rite Valleys. This booklet covers not only recruiting, but also incorporation of new members into the organization, enrichment of their experience once they have joined, and a way to get at the underlying reasons a person decides to drop out. So if you still have a question on how to approach membership issues, that's a great place to start. The challenge starts here: we have to recruit and keep members.

Last year, I strongly recommended that each Valley take the Fourth Degree "on the road". Set up a road show and go to several Lodge halls in your area. Present the Fourth at least, and another Degree if you can. It works. Those Valleys that got the message and spent some preparation time, got results. It takes a team effort with several members to make an appearance at a Lodge meeting, present who we are and what we do. Promise to return with a degree team if there

is interest, and make petitions available. It's a good idea to have the degree presentation already scheduled so Youth Organizations that you can indicate when you will be back.

32° Masonic Learning Centers for Children

Illinois now has all seven 32° Masonic Learning Centers for Children that was originally assigned, up and running. Over 131 children were served in the last semester. When we first started, we were concerned that not enough children needed this type of help. That question has been resoundingly answered. We could fill each Center many times over. Financial support has and continues to be an issue. We need to work to refill the coffers in Lexington that have supported this great work. Your assistance is really needed. Please help the Learning Center Boards ass they go about their fund raising activities.

Youth Organizations

The Illinois Council of Deliberation supports the Rainbow for Girls, Jobs Daughters, and DeMolay. There is a report in these proceedings from the Illinois Masonic Youth Foundation that will give you much greater details. These organizations are so important to us. Please lend your support to them.

Conclusion

As I mentioned earlier in this report, we are challenged. Membership is vital. Keeping what we have and adding new members is the only way we can survive. Leadership under such circumstances is most important. So Let's get the fires burning and show what we can accomplish.

REPORT OF THE COMMITTEE ON PUBLIC RELATIONS

As Public Relations Chairman, you have a roll that offers challenges and rewards to be found in no other assignment.

Your acceptance of this means you have real enthusiasm for the Valley's programs. Those who selected you believe you will tell the Valley's story well. They also consider you reliable and capable of working well with others.

Your job will be to present the news of the Valley to the public. All the information you give should be accurate, complete, brief and timely.

You already have or will soon develop a talent for discriminating between routine Valley affairs and newsworthy events. Both are your concern.

Routine meetings call for routine publicity. Unusual events and special projects merit publicity in depth. They require a great deal more work on your part, but both are worth it. Big events usually warrant special news features.

As Public Relations chairman you will make new, stimulating contacts. You will also find satisfaction in performing an important service for your Valley, for Scottish Rite and Masonry.

Here are twelve basics that I feel are necessary to good Public Relation. I call them the twelve "B's". Be the only contact person to the news media. Be quick to establish personal contact with the right person at all news media outlets in your area. Be sure to write down all information. Train your memory, but don't trust it. Be prompt in meeting dead lines. Be legible, type your releases. Be accurate, double check names, dates and places. Be honest and impartial, give credit where due. Be brief, airtime is costly as well as newspaper space. Be brave. Don't be afraid to suggest something new if you believe you have a workable idea. Media people welcome original ideas. Be business-like. Never pressure friendship or business connections. Be appreciative of all space and time given you. Don't forget, this is free. Be professional. Members of the press are

always invited guest. Never ask them to pay, in fact, give them a special place at your event. Doing the smallest thing may be the trigger that gets you the coverage you want.

One of your biggest jobs is to decide what is news. Broadcasters and newspapers used to carry item after item of what was called "chicken dinner news" but in today's world, world news has crowded it off the news desk into the waste can. You must decide how you can make your event or project interesting to others and not just a news item to your members who most likely already know the facts. Say to your valley, "Give me something to publicize". When members are made aware of the need to do newsworthy things they are apt to develop programs and projects that have good news value. If you're not sure what you have, contact your contacts and ask them what they think.

It is said that an amateur thinks of his story while the professional thinks of his audience. You must think like a professional, which I hope you are, and decide what audience you want to reach. Do you want to build membership? Do you need public support? Would you like to draw area people to you for a fund-raiser? Once you have decided on the audience you want to reach, gear your releases to these groups by using special departments of the newspaper and different Programs on TV and Radio.

In preparing your story remember Name, Phone and Who, What, When, Where and Why. You may want to add a sixth, How.

It is important to get all these points in the first sentence or two. These first sentences are called the lead. A good lead captures the attention of the audience and makes them want to learn more. A poor lead will most likely cause them to turn their attention to something else. Remember, in today's world, time is on every ones mind and the littlest thing will cause them to move on.

In writing your release, type it and double space starting 1/3 the way down the first page. This is to give the editor space to write the header and make notes. If you want, it is OK to use all caps. Do not type on both sides of the page, which should be the standard $8 \frac{1}{2} \times 11$ with $1\frac{1}{2}$ -inch margins on both the left and right. If you have names or words that a person might have trouble pronouncing, include the correct pronunciation. If the release is more than one page, write "MORE" at the bottom.

Does it matter where you article appears? It surely does! Decisions of placement must be left up to the editor. You may ask for a certain place, but remember, it is his decision to place where he wants.

Lets talk about pictures. Most newspapers will print a picture. This may be one that you take or they may come to your event and take the picture. Television is different. A still picture in most cases makes a poor show on air. You must ask if they would come out and cover your story. If your story is newsworthy, they will be there.

Millions of dollars of airtime is given by the broadcast industry every year for public service announcements. To merit a share of this crowded airtime, your news must appeal to a widespread audience.

Broadcast time is limited by the clock. Newspapers can expand their page numbers to conform to the needs of the day. But radio and television stations are limited the hours of the day. In broadcasting, seconds are important and they use them to their best interest. Thus, competition for air time is intense.

When doing interviews, make sure the person you chose to do it is well informed and has the answers to all the basic questions. There is nothing worse than an interview where the person being interviewed does not know the answers. In most cases, the interviewer will cut short the interview.

Don't forget, you cannot control the news and your story. There are often reasons beyond the editor or program director's control. Big news at press or airtime can upset the best laid plans. Just keep your fingers crossed that a great national or local tragedy or triumph won't push your story aside.

Valley of Chicago

Thinking outside of the box. This is the motto that has been adopted by the leadership of the Valley of Chicago, and it continues as the basis for the long-term strategic plan that we have implemented in our full, ongoing, frontal attack in favor of the positive development of our Rite.

The efforts of the Valley of Chicago during the 2007-2008 Masonic year have been focused on four main areas of development, which are, in no particular order: (1) the conceptual design and development of our new home; (2) the requisite for effective communications; (3) the need for unique joining opportunities; and (4) the virtue of positive involvement in the design for membership retention.

The Conceptual Design and Development of our New Home

For some, a building is nothing more than a compilation of brick and mortar that is used as a shelter from nature's elements. To the members of the Valley of Chicago, a building is a grand monument that should be reflective of the purposes for which the structure was built.

The Directors of the Scottish Rite Cathedral Association of Chicago have been working diligently over the past year to conceptualize, design, and prepare to construct, the future home of the Valley of Chicago. The Cathedral Board has entered into a contract for the purchase of a 16.25 acre site in Bloomingdale, Illinois—which is located near the projected center of the Valley of Chicago's instate membership base. We have also been working on the exterior design and interior layout of a 52,000 square foot facility, that when properly adorned, will serve as a stupendous monument of architecture and as a representation of establishment for all Masons in the State of Illinois.

Our new home's design boasts a contemporary design that will include a large foyer and entry space; a dining room; a members' lounge and game room; a traditional Masonic meeting place; a state-of-the-art performance theatre, equipped with the most current lighting, sound, and technological advancements; a library; a museum; and a 32° Masonic Learning Center for Children.

The purpose of our new home is to offer a safe-haven for men to escape the trials and tribulations of human existence; to provide a gathering space for brothers to dwell together in unity; and to encourage the advancement of spiritual growth and human development. Much of our human and capital resources have been devoted to this project, and the skillful advancement of those resources will surely lead to the strength and establishment of the Valley of Chicago for generations to come.

The Requisite for Effective Communications

Communication is a key element in the vitality of any organization–especially organizations, such as ours, that require the unified efforts of its members to productively exist. The Valley of Chicago has worked very hard over the past year to increase the effectiveness of its communications with its members, its Masonic Brothers who have not yet sought membership into the Scottish Rite, and the community in general.

To keep its members informed of upcoming activities and happenings around the Rite, the Valley of Chicago produces a quarterly news journal that is forwarded to members and other interested parties. The journal includes advertisements for upcoming activities; written reviews and pictures of completed events; highlights of various members that recognize fraternal, social, and civic achievements; special interest stories on members' personal and family accomplishments; a tear-out calendar; and other interesting articles on Freemasonry. The Valley of Chicago's news magazine was recognized by the Supreme Council for being the Best Publication in its Class in 2007.

Because the news magazine is published only four times a year, the Valley of Chicago supplements its member communications with a weekly E-News publication, called Echoes from the Valley of Chicago. The Echoes publication highlights upcoming social events and activities, periodic contests, meeting schedules, interactive projects, and promotes various other special news items that are intended to keep the members in touch with the happenings of their Rite. There are currently 1,437 subscribers to the Echoes from the Valley of Chicago, and the subscribers' list continues to grow each week.

The resources that we have dedicated toward improving the effectiveness of our member communications has yielded positive returns in the form of increased participation at Valley activities and larger class sizes at our reunions.

The Valley has also developed and implemented the Ambassador's Program during the 2007 Masonic year. As a direct result of this program, members of the ninety plus Masonic Lodges in our territory, who are not yet Scottish Rite Masons, are receiving communications about the happenings of our Rite. These non-Scottish Rite members, because they are aware of our programs, are bringing their families, neighbors, and friends to Scottish Rite functions and social activities. And because these non-Scottish Rite Masons have been given an opportunity to experience some of the benefits of membership in the Scottish Rite, many of them have decided to petition our Rite for membership status in order to receive the full benefits of membership.

Further, recognizing that the future members of the Valley of Chicago can be found within the Masonic Lodge, we routinely publish Valley of Chicago event advertisements, special news items, and joining opportunities in the Masonic Temple Topics—a monthly newsletter that reaches nearly every member of the Blue Lodges located in the Northeast Area of the State.

We have also been working extremely hard over the course of last year to enhance positive Masonic awareness throughout our communities. In addition to raising nearly \$300,000 in support of our 32° Masonic Learning Center for Children in the last year alone, we have also dedicated our efforts toward other community projects as well. This year, the Valley of Chicago has decided to join the fight against cancer by making the commitment to support the Windy City Classic Celebrity Golf Outing for Cancer Research. Funds raised as a result of this noble endeavor will be donated to the University of Chicago's Cancer Research Foundation and the Susan Warble Foundation.

Other causes that were supported by the Valley of Chicago during the 2007-2008 Masonic year include: the Annual Ride to the Rock, a two-day bicycling

event that raises money for vital research in the area of Multiple Sclerosis; a welcome home care package, containing entertainment gift cards, to American soldiers of the M Company, First Platoon, First Squad Marine Corps Unit, who recently returned home from service in Iraq; and the donation of a Nintendo Wii game system and \$6,000, for the benefit of the Children at Shriners Hospital in Chicago.

As a result of our commitment to increase the positive community awareness of our fraternity, many people who were not previously exposed to the kind and charitable nature of Freemasonry have been brought to light in that respect.

The Need for Unique Joining Opportunities

In April 2008, nearly 200 members of the Valley of Chicago, including nearly 100 candidates, boarded Amtrak's City of New Orleans passenger train for a unique weekend of brotherhood in the Big Easy. The Valley of Chicago, Northern Masonic Jurisdiction, partnered with the Valley of New Orleans, Southern Jurisdiction, to present their Spring Reunion festivities.

Members of the Valley of Chicago made the 1700 mile voyage to New Orleans in style. The Valley of Chicago contracted four private rail cars, including a private dining car, to ensure that members were treated to the most comfortable travel accommodations available. The trip began with a bon voyage party in our own private dining car, where members were served a variety of choice beverages and specialty appetizers. The same degree of elegance continued throughout the journey. All meals during the voyage were served in the Valley's private dining car, including a prime rib dinner on the return trip to Chicago.

The idea of the joint reunion was first developed by Ill∴Gregory R. Klemm, 33°, and the idea quickly gained the support of the leaders of the Valley of Chicago; most especially our forward-thinking Active, Ill∴John T. Phillips, 33°. Ill∴Bro. Klemm and his staff, consisting of Ill∴Lee Bradley, 33°, Daryl W. Selock, MSA; Milan Vydareny; and Edward J. Witas, III, MSA; took charge of the logistical planning and oversaw even the minutest of details which were necessary to successfully complete the Reunion festivities.

While experiencing the mysteries of the Scottish Rite and sampling the New Orleans culture, members were given an opportunity to create friendships that will surely last a lifetime. As a result of the New Orleans reunion trip, the members of the Valley of Chicago are rejuvenated and looking forward to their future involvement in the Scottish Rite. At the completion of the Spring Reunion festivities, the overwhelming excitement of the members heightened as the announcement was made that the 2009 Spring Reunion of the Valley of Chicago would be held in Las Vegas, Nevada.

For those members who were unable to attend the weekend of brotherhood in New Orleans, a special one-day opportunity to join the Scottish Rite was hosted by the Valley of Chicago at the Libertyville Masonic Temple, located in Libertyville, Illinois. In addition to initiating nearly thirty candidates into the Valley that evening, by bringing the Scottish Rite Degrees to the local Lodges, our efforts helped to reinforce the cooperative relationship between the local Lodges and our Rite.

It is important to note that many of the Valley of Chicago's one hundred and sixty plus candidates last year first learned of the benefits of membership in the Scottish Rite from a letter that the Valley sent to newly raised Master Masons informing them of the many opportunities to participate in the extended Masonic community. Through our research, the Valley of Chicago has found that members who have been Master Masons for less than two years are more likely to accept an invitation to seek further light in the mysteries of the Scottish Rite. With these findings in mind, the Valley of Chicago continues to explore new and exiting ways to maximize the participation of our newly raised brothers.

The Virtue of Positive Involvement in the Design for Membership Retention

The Valley of Chicago recognizes that the key to retaining members is to provide them with a variety of benefits that give value to their membership in our Rite. We achieve this goal, in part, by taking the necessary care in developing our future home, by providing effective communications, and by encouraging members to participate in our unique reunions and joining opportunities. However, the Valley of Chicago works very hard to pride its members, their families and friends, with unique activities and social programs that only the Scottish Rite can offer.

In 2007, among the social events that were hosted by the Valley of Chicago include: Day at the Races; a Family Picnic; Family Night at the Rite; a children's holiday party; an adult holiday party; a Valentine's Day dinner and theatre program; and a Chicago Cub's baseball game. One of our most successful events continues to be the Annual Thanksgiving Celebration, where the Valley of Chicago hosts a dinner on Thanksgiving Day, inviting members and their loved ones to celebrate the spirit of the holiday with their Masonic family. The program was originally designed in 2004 for the purpose of bringing together members who did not have anyone to share the Thanksgiving holiday with. But participation in the program continues to grow each year, and it has quickly become one of the most successful programs in the Valley.

What is really encouraging is not just the diversity of the programs that are being offered by the Valley of Chicago, but the participation that our programs are attracting. Nearly every social activity that was hosted by the Valley of Chicago in 2007 was a sold-out event, with a waiting list in place. In many cases every who wished to attend the Valley's programs were accommodated, but the increased participation of our members has created concerns for our event planners, in that all of the events are adopted by our Valley must be able so sufficiently accommodate the demands of our energetic membership—if only we could all have more concerns such as these!

As we are already planning for next year, the Valley of Chicago's social calendar is full of exciting programs and events. Already in the works for 2008 is a Hawaiian Luau and Pig Roast; an outing at Arlington Park; a Scottish Rite Golf Outing; a Family Picnic; a Day at Medieval Times; Family Night at the Rite; a children's and adult holiday party; and much, much more.

As a direct result of the Valley of Chicago's social calendar, members of our Rite, as well as their families and friends, are truly excited about being part of

the Scottish Rite. Our membership recruitment efforts have benefited. Our membership retention and meeting attendance is higher than ever. And this is only the beginning.

There is much uncertainty in the air as the Valley of Chicago pushes forward into the uncertainties of the coming year. Much has yet to be determined when it comes to the on-going development of our new home. But much is clear, the ability of the leaders of the Valley of Chicago to think outside the box, and their willingness to do so, will ultimately lead to the Valley of Chicago's victory in the full, ongoing, frontal attack that has been launched in support of the positive development of our Rite.

The Fall Reunion was highlighted with our welcoming, under the theme of the Reunion Friends and Brothers, the Valley of Chicago for a joint Reunion Weekend. The former Scottish Rite Temple, now Bloomington Center for the Performing Arts, was a beehive of energy and enthusiasm as the members of both Valleys participated in the enjoyable business of conferring degrees and welcoming new members into our Rite. The opportunity to fellowship with our northern brethren was, indeed, exceptional.

The Spring Reunion commemorated the anniversary of the Valley's first class with the theme Rite at 100. The May Reunion was the 100th anniversary of Bloomington Lodge of Perfection beginning to operate under dispensation. The Lodge went on to receive its charter in December of 1908.

The Officers of the Chapter of Rose Croix conducted the Feast of the Paschal Lamb in March. As has been a longstanding tradition in the Valley, the ceremonies included participation by DeMolay Commandery No. 24, Knights Knights of Columbus. Together we commemorated the lives of our brethren and celebrated the divine gifts of life, brotherly love and rebirth.

Family

Numerous activities throughout the year provided opportunities for Scottish Rite families to enjoy events and fellowship together. The Council sponsored a

Family Fun Day at a local Fun Park which features miniature golf, go karts, rides and other games as well as food. The Rite participated in the McLean County Fair, held a Family Picnic at the Scottish Rite Recreation Area at Lake Bloomington, and hosted a Valentine's Dinner.

Certainly, *The American Passion Play* has become a "family" event. The 2008 season was the 85th consecutive year this production was produced in Bloomington. The number of three-generation Scottish Rite families that form the core of the cast and crews is a testament to the importance of our temporal and spiritual families.

Community Service

The Valley recognizes the need to raise awareness of the Masonic Fraternity in general and the Scottish Rite in particular. Throughout the year several of the lines and other volunteers supported Peace Meals distributions, Masonic Community Day activities, and numerous IL CHIP Masonic Lodge sponsored events. We rang the bells for Salvation Army, gave financial support to the Boys and Girls Club, recognized Illinois Scottish Rite Scholarship Award recipitants, jointly sponsored a Blood Drive and sponsored the local DeMolay Chapter.

Scottish Rite Recreation Area

One of the unique assets of the Valley of Bloomington is the Scottish Rite Recreation Area at Lake Bloomington. For better than fifty years this facility has provided a healthy and wholesome environment for numerous events and activities. The RV Camping Grounds accommodates the Scottish Rite Campers Club. The Lodge and picnic pavilion host family reunions, and Lodge and Scottish Rite Picnics. The bunk house and pool support the Illinois Masonic Children's Homes summer camps, Rainbow for Girls State Leadership Camp and other scheduled events through the summer season.

A significant facility enhancement is underway with the construction of the new pool at the Scottish Rite Recreation Area (SRRA). This major investment in the Scottish Rite Facilities at Lake Bloomington is a continuation of the remodeling and refurbishment initiated several years ago to ensure that the SRRA will continue to serve the needs of the membership and affiliated Masonic organizations for many years to come.

We are particularly thankful for the generous contribution from the Illinois Masonic Children's Homes, which covered approximately one-half of the construction cost of the new swimming pool. The Children from the Homes have for some number of years enjoyed a week of summer camping fun at the Recreation Area. I know they will surely give the new pool a workout this summer when they again visit.

So it has been satisfying and productive year for the Valley of Bloomington. But not willing to be comfortable with the status quo, the Officers and Members of the Valley of Bloomington are hard at work planning for the year ahead, and the opportunity to write new chapters of fellowship, service, and fun!

Valley of Southern Illinois

The Valley of Southern Illinois has been extremely active in supporting community events and promoting Masonry throughout our area.

In June we hosted dance recitals for four local dance studios. This brought over 2500 people into our facility. The Valley once again hosted the Belleville Philharmonic Orchestra and The School of Ballet in a presentation of the Nutcracker. On Memorial Day weekend, we hosted the USAF Band of Mid-America for a concert open to the public, all of which allowed us to present Scottish Rite Masonry to the general public.

We continue to have Valley Fish Fry's open to the public. This involves members, wives, and friends to operate and serve to the public. Our Fry's are growing every month and are an additional income for the Valley.

Our Family Life committee started off the year with a Pot Luck dinner which hosted over 85 members and families. They also sponsored a bus trip to the Muny Theater of St. Louis, and helped at three Child ID programs. In February and November the committee hosted holiday luncheons open to our members and general public.

Our 32° Masonic Learning Center for Children continues serving our local communities by providing information on dyslexia, and training of tutors. We presently are working with 30 children in our Center and six new tutor trainees. Since our opening in 2002, we have held 3259 tutoring sessions; served 55 children; trained sixteen tutors; certified seven tutors; 24 children have successfully completed the program.

Our annual Walk-A-Thon held in October was again a tremendous success with over 200 people participating and raising \$13,000 for the Center.

Valley officers attended the ICOD Leadership Conference and completed the strategic plan for 2007 - 2010.





RULES AND REGULATIONS of the Illinois Council of Deliberation

of the Ancient Accepted Scottish Rite of Free Masonry, as amended and adopted June 6, 1964 and as further amended in 1967, 1968, 1970, 1972, 1973, 1976, 1977, 1978, 1979, 1980, 1981, 1984, 1986, 1990 1992, 2001 and 2006.

ARTICLE I Title and Membership

- This Council shall be known as the Illinois Council of Deliberation of the Ancient Accepted Scottish Rite of Freemasonry.
- 2. It is formed under, recognizes the authority of, and acknowledges and yields allegiance to the Supreme Council of Sovereign Grand Inspectors-General of the Thirty-third and last degree of the Ancient Accepted Scottish Rite of Freemasonry for the Northern Masonic Jurisdiction of the United States of America, having its Grand Orient at the City of Lexington, State of Massachusetts.
- 3. It shall be composed of the Active, Active Emeriti, and Honorary Members of the Supreme Council accredited to each State; the Past First and Past Second Lieutenant Commanders of the Council of Deliberation; the Past Commanders-in-Chief of Consistories; the Past Most Wise Masters of Chapters of Rose Croix; the Past Sovereign Princes of Councils of Princes of Jerusalem; the Past Thrice Potent Masters of Lodges of Perfection; those members of Subordinate Bodies in the State who have received the Meritorious Service Award from the Council of Deliberation of such State, the first four elected Officers of Lodges of Perfection, the first four elected Officers of Councils of Princes of Jerusalem, the first three elected Officers of Chapters of Rose Croix, the first three elected Officers of Consistory, as well as the Treasurer and Secretary of Subordinate Bodies, shall constitute a Council of Deliberation for the State of which the Deputy for that State shall be ex officio Illustrious Commander-in-Chief.
- 4. Any Officer of a Subordinate Body of the Rite entitled to a seat in this Council who may be unable to be present at any meeting of this Council, may appoint any member of the body of which he is such officer, his proxy, to act in his stead at such meeting, provided that no such proxy shall represent more than one member of the Council, and provided that such appointment shall be in writing and shall bear the official seal of said subordinate body.

ARTICLE II Meetings

 This council shall meet annually. A special meeting of this Council may be called by the Illustrious Commander-in-Chief, if in his judgement such meeting is necessary and required for the welfare of the Council; or by this Council at any meeting. The Illustrious Commander-in-Chief, with the advice of the Executive Committee, shall determine and fix the place and dates of all meetings, and in connection therewith shall designate the host Valley which shall be responsible for correlating all plans and details of the annual meeting with the designated host city.

- Written or printed notice of each annual or special meeting of this Council shall be given by the Secretary either in person or by mail to each member, not less than ten days prior to the date of such meeting. Such notice shall set forth the time and place of said meeting, and as to special meetings shall set forth the purpose thereof. If mailed the said notice shall be enclosed in a postpaid envelope addressed to each member at his address and same shall then appear upon the records of this Council.
- 3. It shall be the duty of the first four officers of Lodgers and Councils and the first three officers of Chapters and Consistories, unless excused by the Illustrious Commander-in-Chief, to attend the meetings of this Council and to assist in promoting the general welfare of the Rite.
- Accredited representatives of a majority of the Scottish Rite Bodies in the State shall constitute a quorum for the transaction of business.
- 5. The order of business at the annual meetings of this Council shall be fixed by the Illustrious Commander-in-Chief, and in addition to the reception of distinguished visitors, the address of the Illustrious Commander-in-Chief, the reports of committees, the election of and installment of officers, shall consist of such other items as may be placed thereon by the Illustrious Commander-in-Chief.
- 6. The Secretary of the Council shall send a copy of the printed Proceedings of all annual meetings, upon written request, to each member of the Council, and in addition thereto, to each Active and Active Emeritus Member of the Supreme Council.

ARTICLE III Officers of the Council

 At its annual meeting the Council shall elect the following officers to hold office until their successors shall be elected and installed:

The Deputy may appoint such additional officers for the administration of the Council as he shall deem necessary.

- No person shall be eligible to hold any office in this Council unless he be a member thereof.
- In the event of vacancy in any office, caused by removal from the State, absence, resignation, death, or inability to act, the Illustrious Commander-in-Chief may make appointments to fill such vacancy or vacancies, to be in force until the next annual election.
- 4. The Illustrious Commander-in-Chief shall preside at all meetings of this Council. If the Illustrious Commander-in-Chief shall not be present at any meeting of this Council the First Lieutenant Commander, or in his absence, the Second Lieutenant Commander or in the absence of all of them, such member as the Council shall elect, shall preside.

ARTICLE IV Jurisdiction and Powers

- The Council has in its State, legislative and judicial power, not reserved to the Supreme Council and not inconsistent with its Constitution and Regulations and subject to the rights of appeal therein provided.
- The Council may open on the Fourteenth, Sixteenth, Eighteenth, or Thirty-second Degree for the transaction of business relating to the bodies or brethren of those degrees respectively.

ARTICLE V Revenue

- 1. The Illustrious Commander-in-Chief and the Finance Committee shall recommend to this Council a sum to be levied as an assessment on each of the Valleys of the Rite within this State, pro-rated on a uniform per capita basis in such an amount and at such times as may be necessary to defray the expenses and for the proper support of this Council; no such levy shall be made, however, until such time as the Council in annual or special meeting shall have approved the recommendation and voted the amount of such assessment. Any assessment so approved by this Council shall be paid by the respective bodies within ten days following receipt of written notice thereof.
- 2. No subordinate body shall be entitled to representation or a vote in this Council unless and until it shall have complied with the provisions of this Article.
- 3. The minimum annual dues in each Valley in the State of Illinois shall not be less, in the aggregate, than thirty dollars (\$30) per year for membership in all four (4) coordinate bodies of the Rite in that Valley.
 - a. Any Valley may excempt from such dues or any part thereof, (1) any class or classes of out-of-state residents whose permanent residence is at least 500-miles from the Valley headquarters, or (2) any member meeting the qualifications and requirements as set forth in Article 315 of the 1971 Constitution of the Supreme Council, or (3) any member who has paid dues to such Valley for thirty-five consecutive years and reached sixty-five years of age or older.

- b. Unless the By-Laws of any Valley are hereafter amended to provide otherwise, the annual dues of each Valley shall be pro-rated among the four (4) co-ordinate bodies of such Valley in equal shares, share and share alike.
- c. If the annual dues in any Valley equal or exceed twenty dollars (\$20), the annual dues shall include any and all Special Supreme Council Assessments including those assessed against Life Members and others properly exempted from the payment of annual dues, unless that Valley determines, by the majority vote of members of its Lodge of Perfection present at any stated meeting or present at any special meeting called for that purpose, that the annual dues of that Valley shall not include such Supreme Council Assessments.
- d. If the annual dues in any Valley are less than twenty dollars (\$20), the annual dues shall not include any special Supreme Council Assessments unless that Valley determines, by the majority of vote of members of its Lodge of Perfection present at any stated meeting or present at any special meeting called for that purpose, that the annual dues of that Valley shall include such Supreme Council Assessments.
- 4. The *minimum* fees for conferring the degree of the Ancient Accepted Scottish Rite in Illinois shall be:

In a Lodge of Perfection	\$25.00
In a Council of Princes of Jerusalem	25.00
In a Chapter of Rose Croix	25.00
In a Consistory	25.00

Be it further resolved that this Resolution shall become effective June 6, 1992.

- No concessions of any kind shall be made by any body of the Rite in favor of any candidate.
- 6. All monies belonging to this Council shall be deposited promptly on the receipt thereof in one or more financial institutions in the State of Illinois, deposits in which are insured by an agency of the United States government, to be designated by the Illustrious Commander-in-Chief; and such monies shall be subject to withdrawal only on checks signed by any two (2) of the following, namely:-the Illustrious Commander-in-Chief, the Illustrious First Lieutenant Commander, the Treasurer, the Secretary of this Council, and the Chairman of the Committee on Finance.
- 7. All monies belonging to the Hospitaler Fund shall be deposited in an account in the name of this Council in one or more financial institutions in the State of Illinois, deposits in which are insured by an agency of the United States government, to be designated by the Illustrious Commander-in-Chief; and shall be subject to withdrawal only on checks signed by the Hospitaler; provided, however, that in the event of his illness, absence, unavailability, or for any other reason, the Illustrious Commander-in-Chief or Treasurer shall have power to sign checks on such account.
- 8. All securities representing investments of this Council shall be deposited in a safety deposit box in any bank in the State of Illinois, in the name of this Council, and shall be under the control of the Illustrious Commander-in-Chief, the Treasurer, Secretary, and the Chairman of the Committee on Finance. Access to such safety

deposit box may be had by any one of the four (4) foregoing officers of this Council, with the further provision that for convenience the Illustrious Commander-in-Chief may designate any other member of this Council to have access to such safety deposit box in the name of any one of the foregoing officers.

- 9. Every officer and employee of this Council shall commence on the first day of May of each year, and shall end on the 30th day of April in the next succeeding year.
- 10. The fiscal year of the Council shall commence on the first day of May each year, and shall end on the 30th day of April in the next succeeding year.
- 11. Each Valley and its fiscal agent, if any, shall prepare, adopt and operate under a budget governing its annual receipts and disbursements. As required by Art.320 of the Constitutions of 1971, as amended, it shall cause an annual audit to be made. In addition to all other matters, such audit shall compare the actual receipts and disbursements with the budgeted receipts and disbursements. As required by said Art. 320, a copy of such annual audit report shall be submitted to the Illustrious Commander-in-Chief of this Council.

ARTICLE VI Jurisdiction—Degrees and Members

- All bodies of the Rite in the State of Illinois shall have concurrent jurisdiction over all territory within the State.
- The several Valleys of the Rite in the State of Illinois have jurisdiction over all their members, unaffiliated Masons of the Rite within their territorial jurisdiction, and sojourners, for offenses committed within the jurisdiction of such Valleys.

ARTICLE VII

When waiver of jurisdiction is requested from any Valley in another State correspondence relating to the same shall be transmitted through the Deputy of this State.

ARTICLE VIII Discipline

- In all cases against members of the Rite, the procedure shall be according to the Constitution and Code of Trials of the Supreme Council.
- 2. When a member of a Subordinate Body shall owe two years' dues, such Body shall take appropriate action within the year next ensuing. Such action shall be remission of dues or suspension for nonpayment thereof. It shall be within the power of the Council of Deliberation or the Subordinate Body itself to shorten this term.

ARTICLE IX Committees

At such time as he shall deem necessary, or desirable, the Illustrious Commander-in-Chief shall appoint the following Standing Committees, to consist of such number of members as he shall deem necessary, or desirable, and each to continue in office until a new committee, or an individual member thereof, shall be appointed:

- (1) Executive Committee:
- (2) Committee on Credentials:
- (3) Committee on Finance:
- (4) Committee on Audit;
- (5) Committee on State of the Rite;
- (6) Committee on Deceased Members;
- (7) Committee on Jurisprudence, Rules & Regulations;
- (8) Committee on Appeals and Grievances;
- (9) Committee on Reception and Introduction of Distinguished Visitors;
- (10) Committee on Nomination of Officers:
- (11) Committee on Meritorious Service Award;
- (l2) Committee on Public Relations;
- (13) Committee on Citation for Distinguished Service;
- (14) Committee on Membership;
- Executive Committee. The Executive Committee shall consist of the Active Members of the Supreme Council, resident in Illinois, and the Deputies Representatives.
- Committee on Credentials. It shall be the duty of such Committee to pass on the qualifications of every person presenting himself for attendance at each annual or special meeting of this Council and to report thereon at such meeting.
- Committee on Finance. It shall be the duty of such Committee to supervise the finances of, and all monies, securities and properties belonging to this Council. It shall also recommend all assessments to be levied on the respective Valleys for the support of this Council.
- 4. Committee on Audit. The Committee on Audit shall consist of three members of this Council. It shall be the duty of this Committee to audit the reports of the Secretary and Treasurer, and to audit the expense accounts of all officers of this Council.
- 5. Committee on State of the Rite. It shall be the duty of this Committee to study the statistical reports and programs of the several Valleys in this District, and to make such recommendations to this Council concerning the affairs and welfare of the Rite as the Committee may determine.
- 6. Committee on Deceased Members. It shall be the duty of this Committee to report at each annual meeting of this Council the names, addresses, degrees, titles held, and dates of death and other pertinent biographical information of all members of the Supreme Council in this State who have died during the preceding fiscal year, together with similar data on such other outstanding Masonic leaders as it may deem proper.
- 7. Committee on Jurisprudence, Rules and Regulations. It shall be the duty of the Committee to study the Rules and Regulations of this Council; to recommend such amendments thereto as the Committee may, from time to time, deem necessary and advisable; to report to this Council in respect to any such amendment proposed by any other member of this Council; to consider all matters pertaining to the laws and jurisprudence of the Council referred to it by the Council and the Illustrious

- Commander-in-Chief (Deputy); and to make recommendations in respect thereto; and to report at each Annual Meeting of the Council. Its chairman and at least two (2) of its other members shall be learned and experienced in the law.
- 8. Committee on Appeals and Grievances. It shall be the duty of this Committee to consider all appeals from any ruling of the Illustrious Commander-in-Chief, which may be made by any members of this Council or any member of the Rite in this State; to consider all grievances which may come to the Committee's attention; and to report thereon with its recommendations to this Council at its annual meeting or at any special meeting called for such purpose.
- Committee on Reception and Introduction of Distinguished Visitors. It shall be the
 duty of this Committee to attend to the convenience and comfort of all special guests
 attending the annual meeting of this Council, and to introduce them into the Council
 at the instance and upon the invitation of the Illustrious Commander-in-Chief.
- 10. Committee on Nomination of Officers. The Committee on Nomination of Officers shall consist of five members of this Council. It shall be the duty of such Committee to nominate candidates for election to the offices of this Council at each annual meeting.
- 11. Committee on Meritorious Service Award. The committee on Meritorious Service Award shall consist of seven members of this Council. It shall be the duty of this Committee to secure recommendations from the various Valleys in this State on or before April 1 each year and at the annual meeting each year the Committee shall recommend the nominees to receive the Meritorious Service Award.
- 12. Committee on Public Relations. It shall be the duty of this Committee to study the public relations program of the Scottish Rite of this State; to make such suggestions to the individual Valleys that may be of assistance and to co-ordinate and promote proper publicity and public relations for the Rite in Illinois, and to increase and promote a high standard of excellence in the membership publications of each Valley by reviewing such publications regularly and making appropriate recommendations to each Valley from time to time as suggested improvement.
- 13. Committee on Citation for Distinguished Service.
 - (a) Annually, this Council shall cite and present the Distinguished Service Citation to a worthy and well known Scottish Rite Mason who has distinguished himself in the field of religion, government, public welfare and service, business enterprise or professional endeavor. The Scottish Rite Mason to be so honored shall be nominated by a Committee consisting of those members of the Council who have received the citation in the preceding five (5) years, together with such additional members appointed by the Illustrious Commander-in-Chief so that the Committee consists of at least nine (9) members of this Council and each of the nine (9) Valleys is represented on the Committee. The Illustrious Commander-in-Chief shall appoint the Chairman, and nomination shall be subject to the Illustrious Commander-in-Chief's approval.
 - (b)) In consultation with the Illustrious Commander-in-Chief, the Committee Chairman shall select the form of the tangible award, be it a medal, medallion, plaque or framed certificate or scroll and the language to appear thereon. After they reach agreement, it shall be the responsibility of the Council Secretary to

- purchase and acquire the same at the Council's expense and to have it available at the upcoming Council meeting.
- (c) The annual award shall be presented to the nominee at and during the annual meeting of the Council at a point in the program to be designated by the Illustrious Commander-in-Chief. The Committee Chairman shall present the nominee to the Illustrious Commander-in-Chief making appropriate remarks as to the nominee's qualifications. Thereupon, the Illustrious Commander-in-Chief shall present the tangible award for, in the name of, and on behalf of this Council.
- (d) In consultation with the Committee Chairman and the Illustrious Commanderin-Chief, Secretary of the nominee's Valley shall prepare and send to the Illinois Valleys a press release announcing the citation and award, the name and qualifications of the recipient and enclosing, if possible, a picture of the recipient.
- 14. Committee on Membership. The Committee on Membership shall consist of nine members of this Council. I shall be the duty of this Committee to assist the several Valleys in the development and implementation of programs to increase their number of new members and to retain their old members.

The committee shall meet at least as often as semi-annually, one of said semi-annual meetings being held during the Annual Meeting of this Council.

The nine members of the Committee shall be appointed by the Illustrious Commander-in-Chief so as to include one member from each Valley, each to serve for a period of three years. The original appointments shall be made in staggered terms of three members for one year, three members for two years, and three members for three years, so that hereafter the terms of three members shall expire each year.

ARTICLE X Meritorious Service Award

- 1. The Meritorious Service Award shall be given by this Council of Deliberation in Accordance with the provision of the Supreme Council as set forth in Chapter IX, Article 902 of the constitution thereof, and as here after amended. The number of nominees from each Valley in this State shall be based upon the official membership figures of the Lodge of Perfection used in the last Annual Report of the Supreme Council and upon which the per capita for the Lodge was computed. On or before February 1st of each year, the Illustrious Deputy shall set the number that may be nominated that year and shall notify each Valley.
- 2. All nominations for the Meritorious Service Award shall be made, on a form to be approved by the Commander-in-Chief of the Illinois Council of Deliberation, to the Chairman of the Committee on Meritorious Service Award, on or before April 1st of each year. The Committee on Meritorious Service Award shall thereupon report to the annual meeting of the Illinois Council of Deliberation the names of such candidates with the recommendation of the Committee concerning their election. The Committee on Meritorious Service Award may waive irregularities in the form of nomination with the consent of the Commander-in-Chief of the Council of Deliberation.

- Nominations will be made by the unanimous agreement of the Presiding Officers of each Valley. They may nominate less that the number allowable.
- 4. The official jewel of the Meritorious Service Award of the Illinois Council of Deliberation shall be described as follows: The jewel is to consist of two bars and a pendant made of 1/20-12K yellow gold. The top bar is to have a ribbon and a pin bar that will read "Illinois Council of Deliberation" in gold letters on a red background. The second bar is to read "Meritorious Service Award" in gold letters on a red enamel background. The pendant is to be the official Scottish Rite double eagle within a wreath. The eagle and the wreath are to be gold with a black enamel triangle on the breast of the eagle with gold numerals "32". The base of the triangle is to be down. From the top ribbon bar there will be a double folded grosgrain red ribbon to serve as a background for the entire jewel. The name and date of the recipient is to be engraved on the reverse of the lower bar.
- The official jewel as above designated and the official cap as provided for in paragraph 3 Article 1219 of the Constitution of the Supreme Council, shall be provided by the home Valley of the recipient and given to all candidates at the time of the conferral of the Award.

ARTICLE XI Petitions for Degrees and Membership

- Every petitioner for the degrees or for membership must be a Master Mason in good standing, and affiliated in a regular lodge of Symbolic Masons and must have an established place of residence for a period of at least six months next preceding his petitioning for the degrees of the Rite and must have resided in the State six months.
- 2. Any petitioner for the degrees failing to present himself within a period of two years following his election shall forfeit his right to receive the degrees and must present a new and original petition. No body of the Rite shall hold jurisdiction over a candidate residing in concurrent territory beyond the period of two years following his election.
- Each petition for degrees in a Lodge of Perfection shall be accompanied by the full fee therefore as established in compliance with the provisions contained in these Rules and Regulations.
- Publishing the name or names of petitioners for degrees in Valley publications or notices, shall not be required in this jurisdiction, unless otherwise ordered by the Deputy of the Supreme Council for Illinois.
- Dual or plural membership in a Subordinate Body shall be permitted in the jurisdiction of this Council of Deliberation, subject to and in compliance with the applicable provisions of the Constitutions and Regulations of the Supreme Council.

A member of the Scottish Rite to whom a dual or plural membership is granted by any Subordinate Body, shall be subject to and comply with the provisions of the Constitutions and Regulations of the Supreme Council; the Rules and Regulations of the Illinois Council of Deliberation; and shall be amenable to the Rules and Regulations of the Subordinate Body in which he holds a dual or plural membership.

ARTICLE XII Amendments

These Rules and Regulations may be amended by a vote of two-thirds of the members present at any annual meeting of this Council; or by vote of two-thirds of the members present at any special meeting of this Council.

- Except as hereinafter provided, no amendment to these Rules and Regulations shall
 be considered by the Council at its annual meeting unless the proposed amendment
 shall have been first submitted in writing to the Secretary of the Illinois Council of
 Deliberation not less than sixty days prior to the opening day of the annual meeting
 of the Council at which it is to be considered.
- 2. The Secretary of the Council upon receipt of such proposed amendment or amendments shall thereupon and not less that 45 days prior to the opening day of the annual meeting of the Council cause a copy of said proposed amendment or amendments to be mailed to the Chairman of the Committee on Rules and Regulations of the Illinois Council of Deliberation and to the Secretary of each Valley within the Jurisdiction of Illinois.
- Each such proposed amendment shall be considered by the Rules and Regulations Committee, which Committee shall report thereon at the annual meeting of the Council with or without recommendation.
- A proposed amendment may be modified by the Council at its annual meeting, but such modification shall be germane to the subject matter of the proposed amendment and may not go beyond the scope of the proposal submitted.
- 5. The foregoing procedure for the proposal of amendments to these Rules and Regulations shall not preclude the consideration of an amendment thereto at an annual meeting of the Council without prior notice, provided the Illustrious Commander-in-Chief shall have first approved such consideration.
- 6. No proposed amendment to these Rules and Regulations may be considered at a special meeting of the Council unless written notice setting forth the language of the proposed amendment in full shall have been given in writing to the Secretary of each of the Valleys within the Jurisdiction of Illinois and to the Chairman of the Rules and Regulations Committee not less than ten days prior to the special meeting. Any notice posted in the United State Mail not less than ten days prior to the special meeting shall be deemed sufficient notice for such purpose.

ARTICLE XIII Honorary Members

This Council of Deliberation may, at any Annual Meeting thereof, elect distinguished Scottish Rite Masons of this and other States and Jurisdictions to Honorary Membership herein

ARTICLE XIV Subordinate Bodies

- No person shall be eligible for election to any office in any Body in any Valley if he then holds elected office in another Body in that Valley, however,
 - a. A person who is Treasurer of any Body may be elected as the Treasurer of any other Body or Bodies in that Valley; and
 - A person who is the Secretary of any Body may be elected as the Secretary of any other Body or Bodies in that Valley.
- 2. The Presiding Officer of any Body may postpone any stated meeting (except the annual meeting) for not more than 21 calendar days so as to avoid a conflict with a meeting of the Grand Lodge, this Council or the Supreme Council or a legal holiday by first obtaining the advance written dispensation of the Illustrious Commander-in-Chief (Deputy) and by giving written notice of such postponement to all members at least 10 calendar days in advance of the original date.

Supplement No. 11

RESTATED BY-LAWS
OF THE
ILLINOIS SCOTTISH RITE SCHOLARSHIP FUND

ARTICLE I Purposes

1.1 The purposes of the Corporation as stated in its Certificate of Incorporation are:

To receive gifts, bequests and devises of money or property to be used exclusively for charitable purposes: to receive, hold, invest, sell and disburse such funds and properties for exclusively charitable purposes; to engage in charitable enterprises of all kinds and natures; to grant scholarships to worthy persons for education in all fields; to provide funds for research, and for the promotion of charitable enterprises; to engage in various charitable, benevolent, educational, civic, patriotic, scientific and religious enterprises for the promotion of charitable, social and religious ends, and to provide monies under conditions where the purpose is completely charitable in nature.

- 1.2 No part of the activities of this Corporation shall be carrying on propaganda or otherwise attempting to influence legislation. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or for the corresponding provision of any future United States Internal Revenue Law) or (b) by the Corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United Stated Internal Revenue Law).
- 1.3 In the event the existence of the Illinois Scottish Rite Scholarship Fund shall be terminated for any reason, any assets remaining after satisfaction of any contractual or other liabilities shall be distributed to some other organization in the State of Illinois area which itself is formed for the same purposes as the Illinois Scottish Rite Scholarship Fund and which is a qualified donor as described in Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provision of subsequent Revenue Acts to be used for exclusively public purposes.

ARTICLE II Offices

2.1 The Corporation shall have and continuously maintain in this state a registered office and a registered agent whose office is identical with such registered office, and may have other offices within or without the State of Illinois as the Board of Directors may from time to time determine.

ARTICLE III Members

- 3.1 The members of this Corporation shall be co- extensive with the members of the Illinois Council of Deliberation.
- 3.2 The members of the Illinois Council of Deliberation shall have only the right to vote for the election of directors of the Corporation.
- 3.3 The Annual Meeting of the members shall be considered to be the Annual Meeting of the Illinois Council of Deliberation, to be held when and where in accordance with the rules of said Council of Deliberation.

ARTICLE IV Board of Directors

- 4.1 GENERAL POWERS. The affairs of the Corporation shall be managed by its Board of Directors.
- 4.2 NUMBER, TENURE AND QUALIFICATIONS. This Corporation shall be governed by a Board of Directors consisting of (i) by virtue of their offices, the Active and at his request an Active Emeritus Members of the Supreme Council, A.A.S.R., N.M.J.,U.S.A., resident in the State of Illinois plus (ii) one member of each of the several Scottish Rite Valleys located in the State of Illinois. The Directors representing the Valleys shall be elected by the members of the Illinois Council of Deliberation, A.A.S.R., at the Annual Meeting thereof after nomination by the Committee on Nomination of Officers. The terms of said elected Directors shall be for three (3) years with three to be elected each year, except that in the year 1968 five Directors shall be elected. The five so elected, together with the four present Directors whose terms have not expired in 1968, shall determine their initial term of office from 1968 by lot—three for 1 year, three for 2 years and three for 3 years. No elected Director may serve more than two (2) consecutive three (3) year terms.
- 4.3 PLACE OF MEETINGS. Meetings of the Board of Directors of the Illinois Scottish Rite Scholarship Fund shall be held at the following places:
 - a. The Annual Meeting shall be held at the same place inside or outside the State of Illinois as that year's Illinois Council of Deliberation annual meeting; and
 - Any other Meeting shall be held at such place in the State of Illinois or in any other state contiguous to the State of Illinois as is designated in the call of such meeting.

The place of meeting shall be stated in the notice of said meeting.

- 4.4 NOTICE. Notice of any meeting of the Board of Directors shall be given to the members thereof in such manner and form as shall be prescribed by the President. Failure to receive notice shall not invalidate the action of the Board of Directors taken in any special meeting thereof, provided a quorum is present.
- 4.5 QUORUM. A majority of the Board of Directors shall constitute a quorum for the transaction of the business of any meeting of the Board. If such members are not physically present at such meeting, their consent thereto and their approval of any

- action thereat may be evidenced by their signing a waiver of notice of such meeting, and by signing the minutes covering any action taken in any meeting thereof.
- 4.6 MANNER OF ACTING. The act of a majority of the Directors present at a meeting, at which a quorum is present, shall be the act of the Board of Directors, except where otherwise provided by law or these by-laws.
- 4.7 VACANCIES. Any vacancy occurring in the Board of Directors or any directorship to be filled by reason of an increase in the number of Directors, shall be filled by the Board of Directors. A Director elected to fill a vacancy shall be elected for the unexpired term of his predecessor in office.
- 4.8 COMPENSATION. No member of the Board of Directors shall receive any compensation at any time for his services in acting as such Director. No expense of any nature shall be paid to any Director for travel or otherwise, unless expressly authorized at a meeting of the Board of Directors.
- 4.9 ACTION WITHOUT A MEETING. Unless specifically prohibited by the Articles of Incorporation of by-laws, any action required to be taken at a meeting of the Board of Directors, or any other action which may be taken at a meeting of the Board of Directors, or of any committee thereof may be taken without a meeting if a consent in writing, setting forth the action so taken, shall be signed by all the Directors entitled to vote with respect to the subject matter thereof, or by all the members of such committee, as the case may be. Any such consent, signed by all the Directors or all the members of the committee shall have the same effect as a unanimous vote, and may be stated as such in any document filed with the Secretary of State or with anyone else.

ARTICLE V Officers

- 5.1 OFFICERS. The officers of the Corporation shall be President, one or more Vice Presidents (the number thereby to be determined by the Board of Directors), a Treasurer, a Secretary and such other officers as may be elected in accordance with the provisions of this Article. The Board of Directors may elect or appoint such other officers, including one or more Assistant Secretaries and one or more Assistant Treasurers, as it shall deem desirable, such officers to have the authority and perform the duties prescribed, from time to time, by the Board of Directors. Any two or more offices may be held by the same person, except the offices of President and Secretary.
- 5.2 ELECTION AND TERM OF OFFICE. The Illustrious Commander-in-Chief of the Illinois Council of Deliberation shall be, by virtue of his office, the President of this Corporation. The other officers of the Corporation shall be elected annually by the Board of Directors at the regular Annual Meeting of the Board of Directors. If the election of officers shall not be held at such meeting, such election shall be held as soon thereafter as conveniently may be. Vacancies may be filled or new offices created and filled at any meeting of the Board of Directors. Each officer shall hold office until his successor shall have been duly elected and shall have qualified.
- 5.3 REMOVAL.Any officer, except the President or any agent elected or appointed by the Board of Directors, may be removed by the Board of Directors whenever in its

- judgement the best interests of the Corporation would be served thereby, but such removal shall be without prejudice to the contract rights, if any, of the person so removed.
- 5.4 VACANCIES. A vacancy in any office because of death, resignation, removal, disqualification or otherwise, may be filled by the Board of Directors for the unexpired portion of the term.
- 5.5 PRESIDENT. The President shall be the principal executive officer of the Corporation and shall in general supervise and control all of the business and affairs of the Corporation. He may sign, with the Secretary or any other proper officer of the Corporation authorized by the Board of Directors, any deeds, mortgages, bonds, contracts, or any other instruments which the Board of Directors have authorized to be executed, except in cases where the signing and execution thereof shall be expressly delegated by the Board of Directors or by these by-laws or by statute to some other officer or agent of the Corporation; and in general shall perform all duties incident to the office of President and such other duties as may be prescribed by the Board of Directors from time to time.
- 5.6 VICE-PRESIDENT. In the absence of the President or in the event of his inability or refusal to act, the Vice-President (or in the event there be more than one Vice-President, the Vice-Presidents, in order designated, or in the absence of any designation, then in the order of their election) shall perform the duties of the President, and when so acting, shall have all the powers of and be subject to all the restrictions upon the President. Any Vice-President shall perform such other duties as from time to time may be assigned to him by the President or by the Board of Directors.
- 5.7 TREASURER. If required by the Board of Directors, the Treasurer shall give a bond for the faithful discharge of his duties in such sum and with such surety or sureties as the Board of Directors shall determine. He shall have charge and custody of and be responsible for all funds and securities of the Corporation, receive and give receipts for monies due and payable to the Corporation from any source whatsoever, and deposit all such monies in the name of the Corporation in such banks, trust companies or other depositories as shall be selected in accordance with provisions of Article VIII of these by-laws; and in general perform all duties incident to the office of Treasurer and such other duties as from time to time may be assigned to him by the President or by the Board of Directors. The Treasurer shall invest and reinvest the funds, assets and property of this Corporation upon the advice and consent of the Investment Committee.
- 5.8 SECRETARY. The Secretary shall keep the minutes of the meetings of the members of the Board of Directors in one or more books provided for that purpose; see that all notices are duly given in accordance with the provisions of these by-laws or as required by law; be custodian of the corporate records and of the Seal of the Corporation and see that the Seal of the Corporation is affixed to all documents, the execution of which on behalf of the Corporation under its seal is duly authorized in accordance with the provisions of these by-laws; keep a register of the post office address of each member which shall be furnished to the Secretary by such member; and in general perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned to him by the President or by the Board of Directors.

5.9 ASSISTANT TREASURERS AND ASSISTANT SECRETARIES. If required by the Board of Directors, the Assistant Treasurers shall give bonds for the faithful discharge of their duties in such sums and with such sureties as the Board of Directors shall determine. The Assistant Treasurers and Assistant Secretaries, in general shall perform such duties as shall be assigned to them by the Treasurer or the Secretary or by the President or the Board of Directors.

ARTICLE VI Committees

- 6.1 COMMITTEES OF DIRECTORS. The Board of Directors, by resolution adopted by a majority of the directors in office, may designate one or more committees, each of which shall consist of two or more directors, which committees, to the extent provided in said resolution, shall have and exercise the authority of the Board of Directors in the management of the Corporation; but the designation of such committees and the delegation thereto of authority shall not operate to relieve the Board of Directors, or any individual director, of any responsibility imposed upon him by law.
- 6.2 OTHER COMMITTEES. Other committees not having and exercising the authority of the Board of Directors in the management of the Corporation may be designated by a resolution adopted by a majority of the directors present at a meeting at which a quorum is present. Except as otherwise provided in such resolution, members of each such committee shall be members of the Corporation, and the President of the Corporation shall appoint the members thereof. Any member thereof may be removed by the person or persons authorized to appoint such member whenever in their judgement the best interests of the Corporation shall be served by such removal.
- 6.3 TERM OF OFFICE. Each member of a committee shall continue as such until the next Annual Meeting of the members of the Corporation and until his successor is appointed, unless the committee shall be sooner terminated, or unless such member be removed from such committee, or unless such member shall cease to qualify as a member thereof.
- 6.4 CHAIRMAN. One member of each committee shall be appointed chairman.
- 6.5 VACANCIES. Vacancies in the membership of any committee may be filled by appointments made in the same manner as provided in the case of the original appointments.
- 6.6 QUORUM. Unless otherwise provided in the resolution of the Board of Directors designating a committee, a majority of the whole committee shall constitute a quorum and the act of a majority of the members present at a meeting at which a quorum is present shall be the act of the committee.

ARTICLE VII Contracts, Checks, Deposits and Funds

7.1 CONTRACTS. The Board of Directors may authorize any officer or officers, agent or agents of the Corporation, in addition to the officers so authorized by these by-

- laws, to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Corporation and such authority may be general or confined to specific interests.
- 7.2 CHECKS, DRAFTS ETC. All checks, drafts or other orders for the payment of money, notes or other evidences of indebtedness issued in the name of the Corporation, shall be signed by such officer or officers, agent or agents of the Corporation and in such manner as shall from time to time be determined by resolution of the Board of Directors. In the absence of such determination by the Board of Directors, such instruments shall be signed by the Treasurer or an assistant Treasurer and countersigned by the President or a Vice-President of the Corporation.
- 7.3 DEPOSITS. All funds of the Corporation shall be deposited from time to time to the credit of the Corporation in such banks, trust companies or other depositories as the Board of Directors may select.
- 7.4 GIFTS. The Board of Directors may accept on behalf of the Corporation any contribution, gift, bequest or devise for the general purposes or for any special purpose of the Corporation.

ARTICLE VIII Books and Records

8.1 The Corporation shall keep correct and complete books and records of account and shall also keep minutes of the proceedings of its members, Board of Directors and committees having any of the authority of the Board of Directors, and shall keep at the registered or principal office a record giving the names and address of the members entitled to vote. All books and records of the Corporation may be inspected by any member, or his agent or attorney for any proper purpose at any reasonable time.

ARTICLE IX Fiscal Year

9.1 The fiscal year of the Corporation shall begin on the first day of April and end on the last day of March in each year.

ARTICLE IX Seal

10.1 The Board of Directors shall provide a Corporate Seal which shall be in the form of a circle and shall have inscribed thereon the name of the Corporation and the words, "Corporate Seal, Illinois."

ARTICLE XI Waiver of Notice

11.1 Whenever any notice whatever is required to be given under the provisions of the General Not-For-Profit Corporation Act of Illinois or under the provisions of the Articles of Incorporation or by the by-laws of the Corporation, a waiver thereof in writing signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be deemed equivalent to the giving of such notice.

ARTICLE XII Amendments to By-Laws

12.1 These by-laws may be altered, amended or repealed and new by-laws may be adopted by a majority of the directors present at any regular meeting or at any special meeting, provided that at least two (2) days written notice is given of intention to alter, amend or repeal or to adopt new by-laws at such meeting and provided further, that such notice shall not be required if waived in writing by all directors entitled to vote at such meeting, whether or not they be present at such meeting.

ARTICLE XIII Indemnifications

13.1 To the extent permitted by Section 24a of the Illinois 'General Not for Profit Corporation Act', as amended by Public Act 81-413 effective January 1, 1980, (Illinois Revised Statutes 1981, ch.32, *163a 23.1), this Corporation shall indemnify each officer, director and employee of this Corporation as his heirs, legatees, devisee and personal representatives and hold them, and each of them, harmless in any action or proceeding filed or prosecuted against him by reason of his actions or failures to act as an officer, director or employee.


